Open Session

Call to Order

Mayor Moore explained his concerns regarding the Big Spring Economic Development Corporation Executive Director's position that the Big Spring Economic Development Board of Directors has requested to open for applications to be considered and has several concerns with the process, the timeline in which the position is open and some language on the job description. After a brief discussion, comments from several citizens and EDC Board members a motion was made by Council Member Ornelas to replace the current EDC Board of Directors. There was not a second to the motion and the motion

dies due to a lack of second. There was no further discussion at this time.

May 23 meet with staff and voiced his concern 1. request edc to seek applications; 2. appoint 7 citizen members to consider as an advisory committee to look into this matter

purpose of committee - collect resumes, go over resumes and be included in the interviews and make recommendations
